# Delivery Program Operational Plan 2022/23 – 2025/26

Council is pleased to present the 6-month progress report outlining progress in the first half of Year 1 of Councils 2022/2023 Operational Plan and the 2025/2026 Delivery Program. This report outlines the achievements gained in the first half of this reporting year, being from 1 July 2022 to 31 December 2022. The Operational Plan for 2022-23 has 113 actions. Ongoing actions or programs are depicted as being on track at 50% unless otherwise stated with projects represented as the percentage complete for the entire project.

This report will also be made available for downloading via Council's website at https://www.federationcouncil.nsw.gov.au/Council/Corporate-Planning/Reporting. Please also take the time to read the entire report, which includes % achieved, and also many comments as to the status of the actions.

### Some of our milestones this period includes:

- Strategic Asset Management Plan (SAMP) and State of our Council Infrastructure report adopted by Council for local roads, bridges and footpaths.
- Asset Management Strategy completed and road hierarchy being developed.
- Drafting of the Special Rate Variation application is nearing completion. The application will be included on the January 2023 Council meeting agenda for Council endorsement prior to submitting to the Independent Pricing and Regulatory Tribunal in early February 2023. The Strategic Asset Management Plan has also been developed to enable long term planning to guide where funds are invested.
- Updated Masterplan for Lowe Square Recreation Reserve Howlong adopted by Council.
- Major works involving significant walking tracks, signage and river deck areas are continuing across the Corowa Foreshore courtesy of the Crown Reserve Improvement program grant.
- All tenders awarded for the 4 stages of works and works underway for 3 of the 4 stages of the significant renewals and upgrades of the Corowa Saleyards Centre.
- Pedestrian Access and Mobility Plan updated and funding obtained for some works as detailed in the plan.
- Support the Local Emergency Management Committee Committee very active naturally through flooding event in late 2022.

- Provide After Hours Emergency Response Ongoing program and staff were extremely busy and effective in the flooding in the latter half of 2022.
- Council continues to deliver actions from the Arts and Culture Strategy including planning and development of a Reconciliation Action Plan (RAP) for the Federation Council, By the Banks Mural in Mulwala, Murray Arts membership and promotion to the broader community, NADIOC Week and National Reconciliation Week celebrations and activities, library school holiday activities including visit authors, musicians and nature weaving activity. Projects underway include planning for the 2023 Bald Archy exhibition, Historic Photo Art Work in partnership with the Mulwala Library History Group, development of North of the Murray sculpture and mural trails, and Public Art Policy review.
- Funding achieved through Community Events Program to host North of the Murray Event Series.
- Village Flood plain management plans finalised. Council received a grant to progress 4 village flood mitigation design works.


### Key priorities for the next 6 months include:


- Water Systems capacity review expected to be finalised.
