Expressions of Interest – Grazing Licences Sheep Only – Crown Land Reserves

Boree Creek Recreation Ground – Approximately 16 Ha
Boree Creek Golf Course – Approximately 55 Ha

This information pack sets out the terms and conditions associated with obtaining the Grazing Licence for Sheep Only over parts of the Crown Reserves listed above.

Expressions of interest are being called for 4 individual Grazing Licences as described above and shown on the attached aerial photos. Boree Creek may be offered as one Grazing Licence over both offerings depending on Expressions of Interest received.

The Licence period for each will be 5 years and will be subject to the terms and conditions of the standard Crown Land Licence Agreement.

- Stocking Densities
- Weed and Pest Animal Control
- Fencing Maintenance and Repair
- Fire Hazard Control

- Proposed Licence Fee offered.

Evaluation Criteria

Each application will be evaluated based on the following criteria and percentage weighting.

Evaluation Criteria	Weighting
Tendered Price	40%
Demonstrated ability to meet the requirements of the licence.	25%
Provision of management plan	25%
Compliance with Councils insurance requirements	10%

The Council reserves the right to reject/not select any EOI subject to what the EOI applications present.

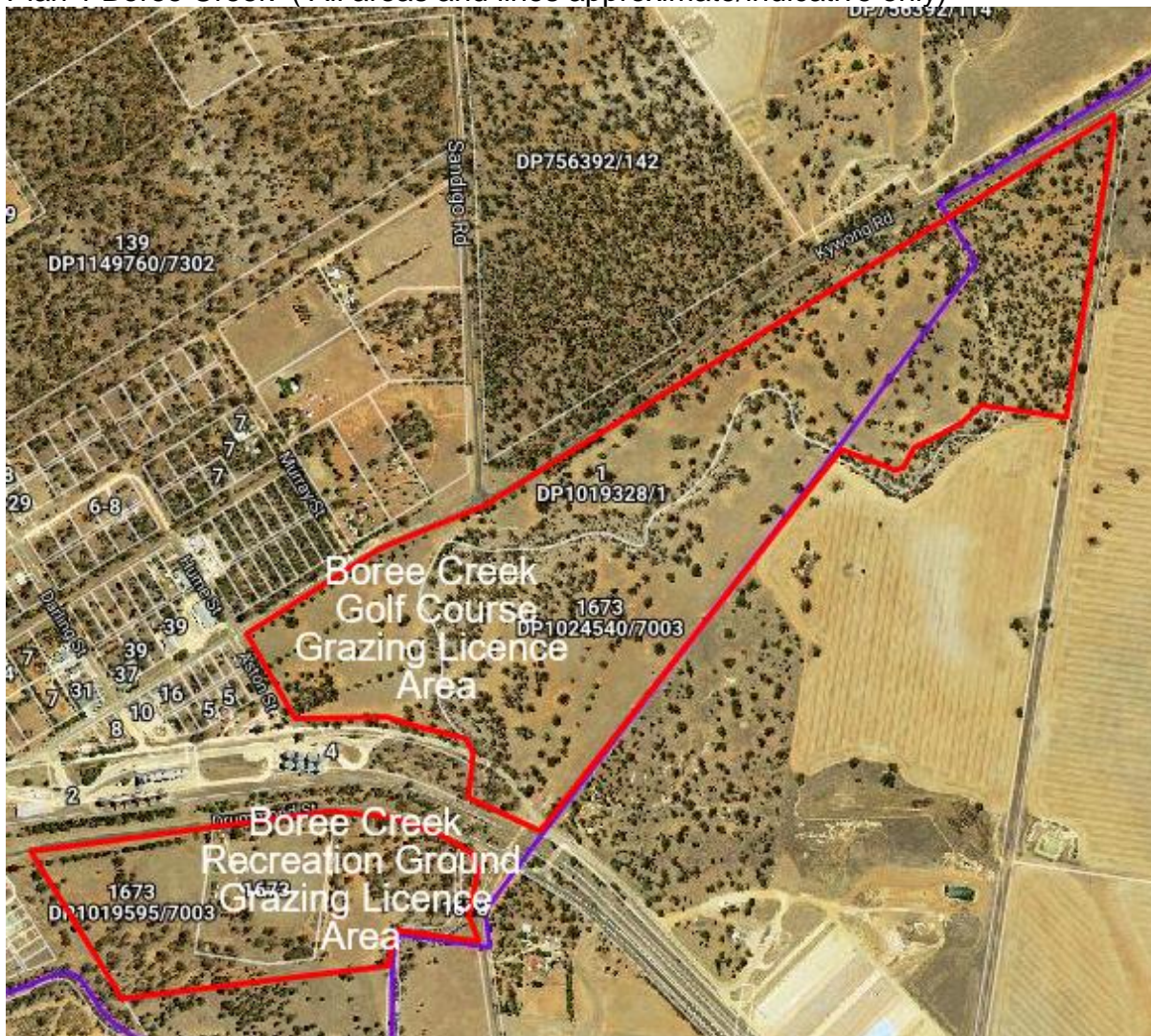
