### FLOOD UPDATE

Flood Watch and Act Warnings are currently in place for Corowa and surrounds, as well as our Rand Village.

The NSW SES has also advised people NOT TO ENTER FLOODWATER due to current widespread moderate flooding in Corowa and rising floodwaters causing flash flooding in Rand. Residents should monitor the situation as it is constantly changing and avoid flood water for your safety. Fast-rising flash flood water is impacting roads, culverts, causeways. This event may change quickly.

Residents are encouraged to stay up to date on the latest information about changes or disruptions to Council Services and operations, as well as road closures, sand bag information and other helpful resources to access during this time from Council's website.
