5. GENERAL MANAGER REPORT

5.1 LOCAL GOVERNMENT NSW ANNUAL CONFERENCE – SYDNEY – 4 – 6 DECEMBER 2017

Summary

This report allows for tabling of summary notes, as an attachment, from the 2017 Local Government NSW Annual Conference for Council, held in early December 2017. The conference was attended by the Mayor, Deputy Mayor, Cr Law and the Interim General Manager.

Background

The conference was considered an extremely useful forum for formal informal interactions between Councillors and staff, politicians, State Government agencies and many other stakeholders. All motions submitted and accepted were able to be presented and dealt with on the first day of the conference.

The conference also saw a new President elected, Cr Linda Scott (City of Sydney) replacing the outgoing President Cr Keith Rhoades, who had served the maximum term under the constitution.

Key Speakers included -

- John Barrilaro MP, Member for Monaro, Leader of the NSW Nationals speaking for Premier who was absent, Keith Rhodes outgoing President of Local Government NSW (LGNSW),
- The Hon. Gabrielle Cecelia UPTON, MBA, BA, LLB MP Member of the Legislative Assembly, Member for Vaucluse, Minister for the Environment, Minister for Local Government, and Minister for Heritage,
- The Hon. Peter Thomas PRIMROSE, B SocStud (Syd) Shadow Minister for Local Government
- Linda Scott (City of Sydney Councillor) New president of LGNSW announced after voting count.

The General Meeting opened at 10.15am on the first day to consider all motions presented and all were dealt with on the day.

5.2 JOINT ORGANISATIONS

Summary

This report allows for tabling of a letter, see attachment, from the Riverina Eastern Region of Councils (REROC) inviting Federation Council to become part of a larger REROC Joint Organisation (JO), to also include Albury City Council. Greater Hume Shire Council are already a part of REROC.

The letter outlines the benefits REROC consider, of having an expanded JO including Federation and Albury City Councils.

Background

JO's are proposed as part of the suite of reforms initiated by the NSW Government and developed in consultation with NSW Councils over the last 6 years. They are aimed to formalise Councils into clusters, to allow for many functions to be carried out more effectively and or efficiently, including planning for delivery of State, Local and even possible Federal actions. It is also considered a way of more easily allowing Councils to engage with the state Departments or agencies, on issues that stretch across Council boundaries. JO's are voluntary to join, must contain at least three Councils, and be generally with the exception of Balranald and Wentworth Councils, be in the current State Planning boundaries. For this region this is known as the Riverina Murray area.

Council has until February 28, 2018 to respond formally to the NSW Government, on the position with respect to if it wishes to be part of a JO, and with what other Councils. As JO's will be legislated, specific wording is required in the resolution, and this will all form part of a report to Councils February 2018 meeting.

Council has workshopped this matter briefly in December, and since that time the Riverina and Murray Region of Councils has met, on the 18th December 2017, to consider the JO matter. RAMROC canvassed all members present, including Federation who was represented by the Mayor and General Manager.

The recommendation that came out of the RAMROC workshop meeting on 18th December 2017 was as follows-

RESOLVED that it be recommended to the RAMROC Member Councils that they resolve to adopt Option 3 in the Executive Officer's report, which proposes the establishment of two joint Organisations within the DoP Riverina Murray State Regional Boundaries, these being a Murray and Murrumbidgee Joint Organisation comprising 11 Council areas (i.e. generally comprising current RAMROC councils), and a Riverina Joint Organisation comprising 9 Council areas (generally comprising current REROC councils);

and noting that Balranald and Wentworth Shires now have an option to adopt full JO membership for a Murray and Murrumbidgee JO.

Council can have further discussion at this meeting and in a workshop, prior to the February meeting, on its final position, but it is required to respond to the REROC request in January, to allow them to meet on the 31 January and have a position on this matter.

The former Urana Shire was a member of both REROC and RAMROC, largely due to its central position across the Riverina Murray area, and with many services, communities of interest and State Agency linkages to the

Wagga area. The former Corowa Shire was a member of both REROC and RAMROC also for many years, but resolved to leave REROC prior to the amalgamation to focus more on RAMROC. This is given the

Financial Implications

The NSW Government has indicated that seed funding of up to \$300,000 per JO is available. Operating costs of each JO are hard to estimate, due to unknown size, final roles and staffing levels, but would be conservatively estimated to be in the order of at least \$500,000 per year. It is envisaged that for RAMROC, the JO would take the place of RAMROC.

Council currently pays \$20,279.47 annually for RAMROC membership, and based on a RAMROC size JO, costing around \$500,000 per year, this would increase Councils contribution to around \$40,000 per year.

5.3 COUNCIL BRIEFING SESSIONS AND WORKSHOP CALENDAR 2018

Summary

This report presents to Council for consideration, a calendar scheduling an allocation of time to bring together Councillors, Executive staff, and other Council Officers, external presenters and trainers as required for specialist areas. It is considered critical to the successful communication, planning, growth and decision making of Council. This report provides for proposed dates and venues twice monthly for the 2018 calendar year. The report aims to reflect discussions by Councillors and staff at the last Councillor workshop held in December 2017 at the Urana offices.

Background

Briefing Sessions

A briefing session is a meeting at which information is discussed less formally, before presentation for a decision at a formal Council meeting. These sessions aim to provide an opportunity for the staff to present an item that is scheduled for a Council Meeting Agenda. It should be presented using a "Briefing Note" template that can then easily be transferred into an Agenda Template after the session and any changes are made based on outcomes of that session. Councillors have the opportunity to ask questions which will assist them with making more informed decisions.

Staff attendance: General Manager and relevant Directors as required, depending on content. Other staff on an as-required basis for presentation and consultation.

Even though briefing sessions are often informal, ground rules for good conduct and communication should still apply as does Councils Code of Conduct. A short time frame for each report topic makes it vital to establish simple rules that make sure others listen when someone is speaking, that communications are to the point and professional, and that encourage questions and productive feedback. The Mayor or their delegate would chair these sessions.

Briefing sessions are proposed to be held on the first Tuesday of the month to allow reports to then be finalised for the Council meetings on the third Tuesday of each month.

Workshops

Time allocated to workshops could be utilised by Councillors to engage in a series of workshops to support newly elected and returning councillors based on the content contained in the Councillor Handbook. Alternatively, Councillors can also elect to nominate specific agenda items relevant to Federation Council including investigating opportunities that may arise from time to time.

Workshops are proposed to be held on the same day as the Council meeting, commencing soon after the close of meeting.

5.4 MEETING DAY – PUBLIC ADDRESS – MICHAEL ROBSON – URANA – OBJECTIONS TO THE CLOSURE OF STEPHEN STREET URANA TO HEAVY VEHICLES

Summary

This report allows Council to consider a letter containing a petition, received from Michael Robson of Urana, requesting to address the Council on the matter of the closure of the local road, Stephen Street Urana to non-local vehicles longer than 15 metres. See attachment. Mr Robson has asked for Council permission to address the meeting, allowable under Councils Code of Meeting Practice and the regulations.

Background

The decision to restrict Stephen Street Urana to vehicles no longer than 15 metres, excluding local traffic, was made via the former Urana Shire Council at the December 2015 meeting. Council received a report on this matter prior to closing the road to these vehicles, requiring them to travel down the B-Double approved William and Woodhouse Streets to continue along Federation Way. Stephen Street is not B-Double approved and is classified as a Local Road, not a Regional Road like the approved route. Notwithstanding this, Stephen Street was widely used prior to this decision by most heavy vehicles as an alternative to William and Stephen Streets.

Council received several letters of objection in February and March 2016 on this decision, and finally the petition and letter from Mr Robson was presented, and due to be considered by Council at the May 2016 meeting. This meeting never occurred due to the amalgamation with Corowa Shire, and the matter has not been dealt with by Council since.

The most recent resolution on this matter was by the Urana Shire Council in March 2016 -

'That Council consult with the Urana Shire Council Community in regards to truck movements through Urana and engage the RMS on this matter.'

Consultation

It is recommended to allow the Infrastructure Services Department to research this issue including obtaining accurate traffic counts, consulting with the Community and transport industry, RMS and other stakeholders and provide further reports to Council on this matter.

6. DIRECTOR CORPORATE AND COMMUNITY SERVICES REPORT

6.1 AUSTRALIA DAY 2018 AWARDS

Summary

Council has partnered with the Rotary Club of Corowa to host a free community event as part of this year's Australia Day Celebrations. Australia Day Awards will be presented as part of these celebrations.

All nominations for the this year's Australia Day Awards were assessed by the Australia Day Awards Selection Panel, comprising community representatives, Councillors Longley and Wales assisted by Council officers on Tuesday the 9 January 2018.

The minutes of this meeting outlining the recommended award recipients have been circulated to Councillors separately to the Council meeting agenda, to ensure the winners are not known until the day.

Background

This year, the Federation Council Australia Day Award Ceremony and Community Celebration will be held at Rowers Park in Corowa on Australia Day Friday 26 January commencing at 10.30am.

The official ceremony will include:

- Presentation of Federation Council's 2018 Australia Day Awards including Federation Council
 Citizen, Young Citizen of The Year, Community Project and Event of the Year, and the recognition
 of the Federation Council Local Achievers.
- Welcome to Country, undertaken by Bpangerang Elder Freddie Dowling
- National Anthem (sang by Corowa's Sing Australia group)
- Ambassador Address Ron Delezio founder of Day of Difference
- Presentation of School Achiever Awards

Council has partnered with Rotary Club of Corowa to organise a community event after the official ceremony. Proposed Australia Day activities include:

- Ski Show by the Mulwala Water Ski Club
- Rowing Exhibition by the Corowa Rowing Club
- Live local performances and entertainment on the river
- Multi-cultural food stalls including Indian, Nepalese, Turkish, Welsh and Aussie BBQ
- Free family fun with river float, cricket and volleyball social competitions, jumping castle and face painting

Australia Day will be an alcohol and glass free event.

- 2. Council adopt the 2018 Australia Day awardee recommendations made by the selection panel and forwarded under separate cover.

6.2 COMMUNITY STRATEGIC PLAN DEVELOPMENT

Summary

Following an expression of interest process and review of submissions, Council has engaged the Centre for Local Government, University of Technology (UTS) to carry out the process of assisting the development of the Federation Council area's Community Strategic Plan (CSP). The project involves facilitation of an extensive consultation and planning process that will culminate in the completion of a Community Strategic Plan for the Federation Council area.

The Community Strategic Plan identifies the main priorities and aspirations for the future of the local government area and must consider other state and regional plans. The development of the plan involves input from council, state agencies, community groups and individuals and requires considerable consultation across these sectors. The key questions addressed by the CSP will be:

- Where are we now?
- Where do we want to be?
- How will we get there?
- How will we know we have arrived?

As part of this project the consultant will assist Council staff to prepare revised planning documentation including a Council Delivery Program and Operational Plan.

Background

Councils in NSW are required to undertake their planning and reporting activities in accordance with the *Local Government Act 1993* and the *Local Government (General) Regulation 2005*. In addition to this The Department of Premier and Cabinet has issued Guidelines that must be followed when undertaking their planning and reporting activities.

The framework for NSW councils includes the development of a 10 year Community Strategic Plan (CSP), 4 year Delivery Program (DP) outlining principal activities to be undertaken by council as identified in the CSP and 1 year Operational Plan.

The Plans are required to be exhibited for a minimum of 28 days before adoption which must be finalised by 30 June in the year following a local government election.

The first inception meeting with UTS was held on 7 December 2017. This meeting enabled finalisation of the scope, project plan and timelines, engagement methodology, key stakeholders and project tasks. Background and supporting information has been provided to support this process. The first milestone for this project will be the development of the Community Engagement Plan, content and schedule for engagement sessions and telephone survey, which is due for completion by 19 January 2018. Please find attached to the agenda for information a copy of the project timeline.

Workshops with stakeholders including Council will be conducted in February 2018 with a draft Community Strategic Plan for further consideration in place by the middle of March 2018 and a draft Delivery Program and Operational Plan proposed by the end of March 2018. This tight timeframe should enable the plans to be finalised for public consultation and adoption, including Councils forward budget, by the end of June 2018, for commencement on 1 July 2018.

6.3 APPLICATION OF COUNCIL COMMON SEAL FOR AUTHORISED OFFICERS UNDER THE SWIMMING POOLS ACT 1992

Summary

Existing delegations of authority under Section 27 of the Swimming Pool Act require amendments and renewals to be approved by Council and a resolution to affix the Common Seal of Council is also required.

Background

Section 27(1) of the Swimming Pools Act 1992 provides the powers for local authorities to appoint authorised officers to perform the functions as required under the act.

Section 27(2) requires each authorised officer to be issued with a Certificate of Identification.

Section 27B of the Swimming Pools Act 1992, authorises officers that have been appointed by Council to enter any premises in or on which he or she suspects that a swimming pool is situated and to examine the premises and, in particular, any swimming pool, and any barrier or other means of restricting access to any swimming pool, situated in or on the premises.

Council currently has three authorised officers with delegated authority, whose Certificates of Identification currently signed by the former General Manager. These officers are:

- Kate Larnach, Manager Planning and Environment
- Christopher Nevins, Health and Building Surveyor
- Stephen McHugh, Health and Building Surveyor

A new Certificate of Identification has been prepared for the above three named officers in accordance with the legislation for the council to be able to perform its delegated functions under the Act.

This power may be exercised with the consent of the occupier of the premises or, if that consent cannot be obtained, at any time after 24 hours' notice (between 9.00 a.m. and sunset) of the proposed exercise of the power has been given to the occupier of the premises.

Holders of a Certificate of Identification do not have the power to enter such part of any building as is used for residential purposes, or any moveable dwelling, otherwise than with the consent of the occupier of the building or dwelling or under a search warrant.

The power delegated by the Council to the officers is required to be made by resolution of council. The Certificate of Identification requires the affixing of the Council Seal in accordance with clause 400(2) of the Local Government Regulations 2005 and a signature of the Mayor or Councillor.

6.4 COMMUNITY EVENTS IN 2018 - INFORMATION

Summary

Council has a number of exciting events coming up over the next twelve months, in addition to the many events that are organised and run by community members and organisations.

Background

Council hosts and supports a number of community events throughout the Federation Council area. Some are small community events and others like the Festival of Fun for Kids and Australian Billy Cart Championships, attract large crowds from outside the area.

Council organised events are primarily funded through sponsorship from local businesses and organisations, state government grants and some council funds.

Coordination of events is the responsibility of the Community Development team, which sits within the Corporate and Community Services Department at Council. Council employs one part time (3 days a week) Events and Community Project Officer and this role also provides support to event organisers in relation to event applications on Council land, risk management requirements and the coordination of traffic management requirements for events.

Council plans to host the following events in 2018:

January

Council has partnered with Rotary Club of Corowa for the *Australia Day Awards and Community Ceremony* on Friday January 26, 2018 at Rowers Park in Corowa.

February

Official opening events will be held at the following parks, to celebrate the completion of these play space projects:

- RSL Park in Corowa.
- Lowe Square Park in Howlong.
- Freddie Fox Park in Urana.

The date of these events will soon be confirmed.

March

Council will host the *Australian Billy Cart Championships* on 31 March 2018 in Sanger Street Corowa. The event is in its 22nd year and is an iconic event for Corowa. In 2017, the event attracted over 5,500 people from across Australia and the direct local economic benefit to Corowa as a result of spectators and participants is estimated to be in excess of \$900,000.

April

Council will host the *Baby Boomers Bus About* as part of the Seniors Week Celebrations from April 4-15, 2018. The *Baby Boomers Bus About* is a series of events across the Council area that are free for seniors to attend. Participants catch a bus from their respective towns or villages and are transported to and from the events. Each event and transport is free.

Held for the first time in 2017, the event sold out within weeks and brought together people from across the Council area. The event provided an opportunity to showcase a number of towns and villages and residents demonstrated a sense of pride.

Council will also host a *Youth Week* event, which runs from April 13-22. This event will be further developed in conjunction with the new Youth Council.

The Community Grants and Event Sponsorship – 2017/2018 (Round 2) will also open in April.

May

Council will host the *Festival of Fun for Kids* on May 20. The *Festival of Fun for Kids* was last hosted in 2014, when it attracted over 6,000 people. The event Facebook page has reached over 30,000 people organically in the last month and is generating an exciting level of interest in the event. Community groups work with Council to present workshops, activities, and performances. The event is a free event for families to attend.

Festival of Fun for Kids School Workshops will be conducted in the two weeks leading up to the Festival of Fun for Kids.

July

Council will host the annual *Volunteer Awards and Celebration* event, which recognises the hard work and dedication of volunteers across the Council area. Last year Council received over 500 nominations and excellent feedback was received from those who attended the celebration event held in Mulwala.

August

Consideration is currently being given to commemorating 125 years since the Corowa Federation Conference 31 July – 1 August 1893 was held at Corowa. The 1893 Conference is attributed to having been the start of the process that ultimately lead to Federation in 1901. If the commemoration takes place, it is proposed that relevant and interested community members and organisations will be invited to lead the celebration with the support of Council.

September

Community Grants and Event Sponsorship – 2018/2019 Round 1 opens.

October

Council will again host the *North East Skate Park Event* in Corowa. The series is popular with young people across the region and the Corowa event was well attended in 2017. Depending on the completion date for the Howlong Skate Park, it is also proposed to include Howlong as part of the NSW Skate Park League event.

December

Council will work with the Disability Access Committee to host an event to celebrate *International Day of People with a Disability*.

Financial Implications

A budget allocation has been made in this year's Operational Plan towards carrying out those events to be held by 30 June 2018. For events after 30 June 2018, a budget allocation will need to be considered in the development of the 2018-19 Operational Plan.







Summary

This report is for the of determination for development application 2017/163 for the demolition of the building known as 'Bay 13" at Lonsdale Reserve, 89 Hume street Mulwala

Property: 89 Hume Street Mulwala – Lonsdale Reserve

Applicant: David Carroll, Federation Council

Proposal: Demolition and Removal of the Building known as "Bay 13"

Background

A report was presented to the September 2017 Ordinary Council meeting for Development Application 2017/163 for the demolition of an amenities block known as "Bay 13" located at Lonsdale reserve Mulwala. At this meeting, it was resolved:

To consider option two in the report and in consultation with user groups prepare a delivery program for bay 13 with consideration towards the Lonsdale reserve Master Plan and available funding.

As a result of this determination, consultation was undertaken with the key stakeholders and at a meeting held on 4 December 2017 (copy of minutes of meeting attached) the Lonsdale Reserve Committee resolved:

That Bay 13 be taken down and replaced with recommended structures of public use toilet and storage facility with kitchenette, with earthworks for improved drainage of Lonsdale Reserve to proceed.

Financial Implications

Council has funds allocated for this project.

RECOMMENDED that Council rescind the refusal of Development Application 2017/163 for the demolition of bay 13 and approve subject to the following conditions

- 1. HOURS OF WORK: All works are restricted to the following times: Monday to Friday: 7am to 6pm. Saturday, Sunday and Public Holidays: 8 am to 6 pm. Noise from the site on Saturdays, Sundays and Public Holidays shall not exceed 5dB (A) above the background noise level when measured at the property boundary.
- 2. PROTECTION OF PUBLIC PLACE: If the building or demolition work is likely to affect pedestrian or vehicle traffic in a public place a hoarding or fence is to be provided.
- 3. The services to the property are to be safely disconnected and capped off. The sewer is to be capped off and location identified for future connection.
- 4. ASBESTOS: Development involving bonded asbestos material and friable asbestos material.
- (a) Work involving bonded asbestos removal work (of an area of more than 10 square metres) or friable asbestos removal work must be undertaken by a person who carries on a business of such removal work in accordance with a licence under clause 318 of the Occupational Health and Safety Regulation 2001.

- (b) Work involving bonded asbestos removal work of an area less than 10 square metres may be undertaken by a person who complies with (a) above or who complies with the requirements of WorkCover. Contact WorkCover Assistance on 131050 or visit the WorkCover website at www.workcover.nsw.gov.au.
- (c) The person having the benefit of the construction certificate must provide the principal certifying authority with a copy of a signed contract with such a person before any development pursuant to the construction certificate commencing.
- (d) Any such contract must indicate whether any bonded asbestos material or friable asbestos material will be removed, and if so, must specify the landfill site (that may lawfully receive asbestos) to which the bonded asbestos material or friable asbestos material is to be delivered.

In this clause, bonded asbestos material, bonded asbestos removal work, friable asbestos material and friable asbestos removal work have the same meanings as in clause 317 of the Occupational Health and Safety Regulation 2001.

- Note 1. Under clause 317, removal work refers to work in which the bonded asbestos material or friable asbestos material is removed, repaired or disturbed.
- Note 2. The effect of subclause (1) (a) is that the development will be a workplace to which the Occupational Health and safety Regulation 2001 applies while removal work involving bonded asbestos material or friable asbestos material is being undertaken.
- Note 3. Information on the removal and disposal of asbestos to landfill sites licensed to accept this waste is available from the Department of Environment, Climate Change and Water.
- Note 4. Demolition must be carried out in accordance with Australian Standard AS 2601-2001, Demolition of Structures.

LOCAL GOVERNMENT NSW ANNUAL CONFERENCE – SYDNEY – 4 – 6 DECEMBER 2017

Summary of key speaker addresses/forums

Speaker - John Barrilaro MP, Member for Monaro, Leader of the NSW Nationals – speaking for Premier who was absent

- NSW continues to be the economic engine room, unemployment is around 4 6. %, record
 infrastructure investment by the State, recording budget surpluses with low Government
 debt, constructing enabling infrastructure for road and rail, stadiums, schools, hospitals, with
 a balanced budget.
- Announcement of the 'Stronger Country Communities fund of \$200 million, allocation to each Local Government Area to deliver priorities to communities.
- \$36 million dollars for Telecommunications for black spot mobile phone areas, in a partnership with the Federation Government.
- New start-up businesses can leverage off nbn and opportunities around wi-fi, with \$50 million available in that fund.
- \$100 million allocated towards cultural and arts facilities in the regions along with the regional growth funds.
- \$7.6 billion allocated for new and refurbished hospitals.
- \$4.2 billion allocated for Education, with \$2.2 billion over the next two years.
- Roads rails schools and hospitals is the focus for the State Government, creating 220,000 new
 jobs, including small business jobs.
- Courage is shown by businesses and the State Government is promoting its 'Small Business
 Friendly' program making it easier for those businesses to operate by cutting regulations
 where possible.
- Congratulated new Councillors, and spoke of changes to the Environmental Planning and Assessment Act to improve planning in our communities. Stressed the importance of local character and amenity in planning, and to do it in consultation with developers and in partnership to Local Government.
- Constitutional recognition for Local Government via a referendum should be back on the table, to recognise the three tiers of Government.
- The 'Fit for the Future' program despite controversial mergers aims to ensure Council can balance their books, get recognition, and access more funds from the State and Federal level.
- We continue to see the investment, we have great cities, skills and small business, and a strong local economy, with NSW representing 48% of National Economic.

Questions from the floor to Mr Barillaro

Cr Dan Hayes (Wagga) – queried Mr Barillaro on the low levels library funding - Mr Barillaro advised that the Premier and Cabinet are discussing policy ideas, and library funding is at the top of his list, and is more than happy to come back when he knows more.

Cr Bill West (Cowra) - with the growth in state, and Sydney being the greatest contributor to gross domestic product, and with the regional growth, including across central NSW, it is critical for the State to preserve a corridor along the Bells Line of road - Mr Barillaro advised that the record investment in connectivity, regional airports will help the agricultural sector, which puts funds back into the state economy, to ensure a growing local economy. The Bells Line of road is not in current transport plan, but Roads Minister Pavey yesterday spoke about considering the Bells Line of road, and the fast train project.

Other question – On TAFE, when is the State Government going to commit to a fully funded model - Mr Barillaro advised that the disruption is occurring with the State and Federation Government not

being able to commit to a partnership yet, but there is \$2.2 billion in the skills budget, including \$130 million in capital expenditure. Reforms are occurring around TAFE, and he knows the value of TAFE. Other matters for the government including opening up to asylum seekers, focussing more on domestic violence,

Other question — on IPART review of Local Government and where is up to - Mr Barillaro advised that it will be important going forward, and that rate pegging should be scrapped. Development and green space is a concern, and the Department of Planning is drowning in planning proposals, in some areas there are linear parks and school spaces that are not good enough, and they need to step plans up, Ministers of Government and the Premier said publicly that a greater focus is to be placed on green spaces, with more than a few open areas, and they want projects coming forward, to find a balance between development and the environment.

Keith Rhodes – outgoing President of Local Government NSW (LGNSW)

LGNSW seek a true Partnership with the State Government, including in improving housing affordability.

LGNSW deliver Leadership and value, with examples such as the Mayoral Mentoring program, development of the new Local Government Capability framework, which is a game changer for the sector. LGNSW also assist Councils in recruiting, and professional development for elected representatives. LGNSW has reviewed its governance principles and is committed to good governance for Councils who continue to work to serve their community openly and honestly. The new code of conduct is rigorous and brings in new rules around not even being allowed to accept the offer of a coffee.

General Meeting opened at 10.15am to consider all motions presented.

Speaker - The Hon. Gabrielle Cecelia UPTON, MBA, BA, LLB MP - Member of the Legislative Assembly, Member for Vaucluse, Minister for the Environment, Minister for Local Government, and Minister for Heritage

- No more forced mergers of Councils, Government is working hard on supporting Councils with integrity, with no more changes. 500 new councillors were welcomed in September, who have been given great responsibility and privilege, with challenging opportunities to make a difference.
- Professionalism and integrity are key, and Local Government has challenges. The State Government has introduced a package of measures as part of the integrity reforms, to ensure good governance. These include caveats for property developers to be banned from public office where appropriate. The recent inquiries into Auburn and Murray Councils and others are a reminder that some councils are failing the community. The NSW Government makes no apology for stepping in to fix councils, to protect the reputation of hard working councillors.
- Integrity is at the heart of what is released in the new code of conduct. Focus on eliminating bullying, and improving meeting behaviour, and transparency, including lowering threshold for reporting of gifts. Ensuring returns of interests are completed correctly, provides protections for the majority of councillors who are doing the right thing. Government will act more clearly on bad behaviour early. Submissions on the new code closed on December 4, 2017, and it will be adopted early 2018. Councils have six months to adopt it.

- Also, a new set of meeting rules is proposed for across the state, including focusing on the use of technology. Most people are time poor, and we can't expect all ratepayers to attend meetings, so mandatory web-casting is on the table. Some are mandatory provisions, but others are voluntary provisions. Immediately before the meeting Councillors are to be briefed on agenda items. An exhibition will be done until mid-March 2018, with six months to adopt the new rules.
- There are draft guidelines for professional development of new Councillors, to help Councillors maintain and improve knowledge and skills, with all to have access to it, and Councillors must make all reasonable efforts, and Councils can publish attendance on the website of Councillors who attend training and workshops.
- Over the past few years, The State Government and the Local Government sector have worked hard across the state to improve services, with many Councils reporting strong performance. The Financial sustainability of Councils is a strong focus with the infrastructure backlog well down, with only 30 councils reporting with surpluses in 2010, compared to 114 in 2017.
- Performance audits will be continued to identify the good practices, and make recommendations where improvements are required. Access to new Treasury TCORP loan scheme is now available, with \$290 million of loans already in place to Councils to improve community facilities.
- A small number of councils still need to demonstrate they have a plan, and residents need to know how things are going,
- The Joint Organisation (JO) establishment will drive better planning, service delivery, and can greatly transform the way Local and State Governments work together, and even with the Federal Government. Design criteria is still being established, with \$3.3 million available to JO's in seed funding. This is the maximum funding if all Councils join, with around \$300,000 for each JO. The Pilot JO's have shown how it can work, with the Namoi group producing an investment prospectus, for a new global market for job opportunities, and a regional freight transport plan being delivered by REROC. Councils will get a better seat at the table in a JO, and are encouraged to take it up. The JO's will be up and running by July 2018, improving service delivery.

Speaker - Ellen Fanning

Councillors are engaged with ratepayers to build the communities for future, with a dialogue with council. Issue with trust deficits in institutions and what does that mean.

Speaker - The Hon. Peter Thomas PRIMROSE, B SocStud(Syd) MLCPeter Primrose Shadow Minister for Local Government

Spoke of the great work of Keith Rhodes LGNSW who is the outgoing President.

- Spoke of the opportunity he has had over last few years to meet with so many Councils, and the conversations had, around the forced mergers and Fit for the Future.
- Congratulated those Councillors elected, and has most fondness for his time on Campbelltown City Council.
- There is a huge amount happening in Local Government, with the forced mergers debacle over the last few years. Still fighting the State Government for the release of the figures used to try and justify forced mergers, as there is belief that the information contains a list of areas to be forcibly merged in the future. Believes the State Government still thinks there are too many councils, especially in Sydney.
- Very proud because of a Labour Party Council resolution passed, that there is now a policy to oppose forced council mergers now and in the future. Has no problem with voluntary mergers, and the next State Labour Government will allow votes to be held to allow forced

merged Councils to de-merge where the community is in favour. He is attracted to the approach used in Queensland for this purpose.

- Joint organisations when the Government introduced the bill, it got bi partisan support, but supported only voluntary JO's. Did not support the non-allowance of Sydney Councils to be in JO's also. The Government argues the Greater Sydney Commission does this work, but he considers it is to stop them being stronger. The JO legislation is a mess, and there is no mechanism to get out, but they will work with the Government to make it work.
- Independent Hearing and Assessment Panels (IHAP's) and Local Planning Panels proposed for Sydney Newcastle and Wollongong councils at the heart of the anti-democratic bill is that the panels will be more subject to corruption. The opposition amendments were to require the panels to not meet in secret, with all records to go on the website, and funding should come from the Government. But this was voted down. It is not a labour bill, and there is no desire to retain it when they return to Government.
- Will abolish priority precincts; they cannot stop the current Government introducing it, but they can review it when in, and they are committed to find better ways to do planning in NSW.
- Count-backs instead of bi-elections when a Councillor is lost, in certain circumstances is supported and passed.
- On the issue of merging funding, the Government 2017/18 budget paper 1, states that \$110 million should still be available for Local Government. The finding costs of merger for some are way above what was funded, so why isn't the \$110 million available. The political ad campaign compromised value for money, with \$4.5 million wasted. Hospitals and schools should be a priority over stadiums.
- On Libraries, the NSW State Government provides the lowest per capita of all states, only 7% compared to around 26% in the 1980's.
- Re-confirmed that next Government will put Local Government constitutional recognition back on the agenda, and a legislative inquiry into Local Government.
- The LGNSW report estimated that cost shifting cost \$680 million every year, and endorses to provide in the next budget a detailed breakdown of Local Government funding by state, to increase budget transparency in NSW. Willing to visit any Council to discuss further.

Office of Local Government

Meeting was held with Office of Local Government representatives Director Chris Presland and Support Office Karen Legge, Councillors and the Interim General Manager, to further discuss the Joint Organisation model – refer Councillor workshop and Council reports for further information.

Micromex presentation on their research into Local Government

Confirmation bias is present where you hear want you want to hear from certain people, looking for the future, we are all here to work to make things better, Where are we now , what are their needs and what do they want to see to meet them.

In 2011, on Local Government brand and image, and the perception in the broader community, Micromex did a state-wide survey of NSW, and of the drivers that contribute most to performance, the top three are responsiveness, competence and listening. Performance measures are important but values and vision are more important.

In 2017 where are we now, well it has been a roller coaster since 2012 with the reforms, and beyond the research done in past, 61% of people think things are good to excellent. Also, don't ask for input if your mind is made up.

Proposal for an Expanded Eastern Riverina JO

I write on behalf of the Board of the Riverina Eastern Regional Organisation of Councils (REROC) to formally raise a proposal which we have previously discussed informally in relation to the formation of an expanded Eastern Riverina Joint Organisation (JO) that would include Albury City Council and Federation Council.

Our Member Councils are well aware of the long-standing commitment that Federation has to RAMROC and this proposal in no way is intended to undermine that strong relationship. However, we believe that it is important that we canvass all alternatives in relation to the new JO boundaries and our Member Councils believe that a JO which includes Albury and Federation is worthy of serious consideration.

We believe that this JO boundary will:

- Deliver a larger footprint that creates a north-south corridor which takes in most of the major transport routes in our region.
- · Make for a stronger JO because it will include two regional cities.
- Create a definite eastern Riverina "block" of councils with a recognisable community of interest.
- Open doors to more funding for the Region.
- Facilitate regional planning outcomes
- Build on the existing relationship we have with Albury and particularly with Federation, whose predecessor councils were both members of REROC.

It has always been REROC's stance that councils should choose what JO they belong to and that the choice should be informed by where the council believes it will receive the best return on its

investment. Therefore, if Federation Council does not wish to consider the proposed option, we will advise our Member Councils and move on to our second preference boundary which is a JO based on the current REROC boundary.

We would be happy to discuss the matters raised in this letter with Council if invited to do so. The next meeting of the REROC Executive will be held on 31 January and our Board next meets on 1 February. It would be appreciated if you could provide us with your advice on the matters raised in this letter in time for those meetings.

I take this opportunity to wish you, the councillors and staff of Federation a happy and safe Christmas and New Year.



207 RTA may provide financial and other assistance to roads authorities for road work on classified roads

- (1) The RTA and a roads authority may enter into, and may perform their obligations under, an agreement under which the RTA provides financial or other assistance to the roads authority to enable it:
 - (a) to carry out specified road work or specified traffic control work on a specified classified road, or
 - (b) to carry out road work or traffic control work generally.
- (2) Under an agreement of the kind referred to in subsection (1) (a), the RTA is liable to pay to the roads authority:
 - (a) the whole of the cost of the road work or traffic control work, in the case of work to be carried out on a main road, or
 - (b) no less than half of the cost of the road work or traffic control work, in the case of work to be carried out on a secondary road, or
 - (c) such part of the cost of the road work or traffic control work as the RTA determines, in the case of work to be carried out on a tourist road.

unless the roads authority notifies the RTA that it is prepared to accept a lesser amount.

208 RTA may provide financial and other assistance to roads authorities for by-passes etc around classified roads

The RTA may grant financial assistance to a roads authority for the purpose of meeting costs incurred, or to be incurred:

(a) in carrying out road work on an unclassified road that adjoins a classified road, or



in restoring an unclassified road that has suffered damage because of its use as a by-pass or detour in order to avoid a classified road, or

in carrying out road work on an unclassified road if, in the opinion of the RTA, the carrying out of the work would be of benefit to a classified road in the vicinity of the road on which the work is being carried out.

A letter has been received from Mr Michael Robson, see attached, with a request to address Council at the May meeting on the heavy vehicle issues in Urana.

Recommendation

- ii) That receipt of the letter and attachments from Mr Michael Robson be acknowledged and that it form part of the community consultation to be conducted in relation to this matter.

Background

At the March Meeting the following resolution was passed by Council:

"That Council consult with the Urana Shire Council community in regards to truck movements through Urana and engage the RMS on this matter."

Mr Lindsay Tanner, the RMS Regional Manager was invited to Urana to discuss the matter with Council Officers and the Mayor on the 22nd April 2016.

General discussions were held and the sites inspected. Further discussions will be held with RMS when options are developed. Alternative routes were inspected as well as upgrade options for the existing main Road (William and Woodhouse Streets). Mr Tanner indicated there would be limited funding available through RMS for alternative routes.

A funding proposal has been submitted under "Fixing Country Roads" for the reconstruction of the existing road pavement along William and Woodhouse Streets for 2017/18.

The Consultation process with the Urana community is still to be arranged. Meanwhile traffic count data is being obtained to help inform future decisions.

Background

The Council resolution from the December 2015 Council Meeting is as follows:-

- *That Council note the report on the possible closure of Stephen Street, Urana to heavy vehicles;*
- ii) That Council adopt the recommendation of the Urana Local Traffic Committee to restrict traffic longer than 15 metres using Stephen Street, Urana.

Cr. Marsh asked that his vote against this motion be recorded.

The report by the then Director of Engineering, David Graf, to that meeting listed the following reasons for that recommendation:

"An increasing number of trucks are using Stephen Street (from MR385 Federation Way north east of Urana township to MR131 William Street Urana at the southern edge of the town) as a short-cut, and not the designated Main Roads route via William and Woodhouse Streets, Urana.

The opening of the new bridge over the Murray River at Corowa is causing more trucks to use Federation Way possibly to avoid the safety camera at Jerilderie.

The use of Stephen Street by heavy traffic is undesirable for various reasons including:

- i) The local street was not built to cater for heavy traffic and the pavement has been damaged. A heavy patch was recently done near William Street and the screwing heavy traffic is a major cause of the problem.
- ii) Heavy traffic occasionally use their engine brakes which interrupts peoples sleeping habits. A number of people have complained regarding the problem.
- iii) Heavy traffic can be dangerous and I personally experienced a near miss whilst recently exiting Fredrick Street.
- iv) Council receives no funding from RMS.
- v) Sections of the designated route, William and Woodhouse Street (MR 385 Federation Way) are narrow and require rehabilitation.

The proposed restriction generally seeks to restrict heavy through traffic but allows buses to still use the road, while local heavy traffic travelling to a site within the town, are exempt from the Length Limit.

A copy of the Urana Local Traffic Committee report is attached."

The situation has not changed since Council's original resolution, that it was to reinforce the existing situation and have heavy vehicles use the designated route along William Street, which is classified as a Main Road, and not a Local Road (Stephen Street), attracting additional funding.

As indicated in the previous report, Council has incurred substantial cost in maintaining the Stephen Street route due to heavy vehicle damage, particularly at the William Street intersection.

Stephen Street is not designed to cater for large heavy vehicles with poor visibility at some residential street intersections and curves. It also has a narrow formation width which is unsuitable for heavy vehicles when they meet on the narrow curved section.

Pedestrian safety is considered adequate along the William Street route with a school crossing, and speed zones in place. Council has recently constructed improved footpaths along sections of this street, which has also improved pedestrian safety. Further there are no cross streets intersection at dangerous points as is the case with Stephen Street.

Council will place traffic counters along William Street to measure the number and types of vehicles. This will be useful data, along with the support of affected residents, to lobby State and Federal Governments for funding to construct a proper by-pass.



National General Assembly of Local Government Call for Motions Discussion Paper

Australia's Future, Make it Local

The purpose of this discussion paper is to provide guidance to councils for the development of Motions for debate at the 2018 National General Assembly. The paper provides an overview of policy areas in which the NGA has well-established positions and identifies potential new and emerging policy areas which are being developed by ALGA and require detailed consideration. Councils are particularly encouraged to submit Motions on these policy areas.

Highlighting the issues below contributes to implementing ALGA's Strategic Plan 2017-2020 and its objectives to:

- strengthen Local Government in the areas of financial sustainability; delivering services in regional cities; infrastructure; and innovation and digital transformation, as well as,
- facilitating collaboration between state and territory associations in Local Government's role in Indigenous policy issues, scale and capacity; women in Local Government; and diversity in representation.

Criteria for Motions

Motions must meet the following criteria:

- ✓ be relevant to the work of local government nationally
- ✓ be consistent with the theme of the NGA
- ✓ complement or build on the policy objectives of your state and territory local government association
- ✓ be submitted by a council which is a financial member of their state or territory local government association
- ✓ propose a clear action and outcome
- ✓ **not be advanced** on behalf of external third parties that may seek to use the NGA to apply pressure to Board members or to gain national political exposure for positions that are not directly relevant to the work of, or in the national interests of, local government.

Your Opportunity

The primary focus of all Motions should be to strengthen the capacity of local government to provide services and infrastructure in Australia. Providing clear actions within areas that are still emerging provides councils with an opportunity to influence the development of ALGA policy and advocacy by ALGA on federal election commitments.

Emerging Issues

Councils across Australia are constantly being asked to do more with less. Changing community needs, including ageing populations, technological advancements and changing economic circumstances, are a challenge for all communities.

Analysis suggests that a Commonwealth election may well be called between August 2018 and May 2019. The 2018 NGA therefore provides an important opportunity to progress Local Government issues in the Federal agenda. Below are some critical areas in which Local Government needs to consider the role it can in local communities on the national stage. In particular, the 2018 NGA is calling for Motions that provide clear policy advice and/or policy initiatives that will help Local Government to address the following policy challenges:

Housing Affordability

Housing affability is a major challenge in many communities. The Commonwealth frequently asserts that housing affordability is a problem because of the supply of housing. As such there has been a focus on planning reform.

Motions are called for on ways to improve housing supply and improve land use planning and associated local government infrastructure to support increased housing supply.

Financial Sustainability - Oppose Cost Shifting

In 2005 The House of Representatives Inquiry into Cost Shifting from States onto Local Government estimated that cost shifting amounted to between \$500m - 1.4b annually. This includes regulatory and other services that Local Government provided on behalf of states without adequate compensation.

Motions are called for on ways to reduce cost shifting from states and the Commonwealth on to Local Government and on areas of regulatory reform and services that Local Government could provide efficiently and effectively on behalf of states or the Commonwealth if appropriately funded.

Innovation and Digital Transformation – Smart Communities

Technological advancements are changing the way councils communicate with citizens and deliver services and infrastructure.

Motions are called for on ways to improve the ability of councils to support their community to understand and benefit from digital transformation, ways to improve data, protect privacy and increase security of council-held data.

Harmonising Local Government Data

National Local Government data is held in a variety of places and is often of variable quality. National advocacy on behalf of Local Government needs a strong evidence base. ALGA has been working with JRA on the State of the Assets project which collects data on the quality and condition of all local government assets. Increasingly, councils are being required to provide data to third parties.

Motions are called for on ways to improve the collection of local government data, how data could be better linked across the sector, and ways to improve the quality of data.

Cyber Security

Recent malware attacks have highlighted the vulnerability of business and government computer systems. Strong measurers are required to ensure that all Australians and Australian businesses and governments are aware of the risks and take appropriate measures to ensure cyber security.

Motions are called for on ways to improve local government cyber security.

Environment

Local Government plays a critical role in environmental management, with actions often embedded into other day to day operations as well as included in economic management considerations

Motions are called for on what should be national priorities and on ways to improve environmental management systems, waste management, product stewardship and biodiversity.

Regional Development

Local Government plays a critical role in regional development, with an active role working with neighbouring councils, industry, state government agencies, community and other key stakeholders to set and achieve regional goals.

Motions are called for on ways to improve regional policy approaches, funding ideas on regional sustainability and equity.

Motions should be lodged electronically using the online form available on the NGA webpage at: alga.asn.au. All Motions require, among other things, a contact officer, a clear national objective, a summary of the key arguments in support of the motion, and the endorsement of your Council.

Motions should be received by ALGA no later than 11:59pm on Friday 30 March 2018.

Established ALGA Policy Areas

Financial Assistance Grants

Adequate and appropriate Local Government services and infrastructure are critical to all communities. The Commonwealth Financial Assistance Grants are important to all councils. Success has been achieved in the last 12 months by restoration of the indexation of the Financial Assistance Grants (FAGs). ALGA's priority in this area is to continue advocating for FAGs funding to be increased to a level equal to at least one per cent of commonwealth taxation revenue.



Freight Strategy

Local government manages around 75 per cent of Australia's local roads network. These roads were generally built decades ago and today are required to carry increasing amounts of freight, including higher productivity vehicles. Poor and unsafe roads are a barrier to increased productivity. ALGA's priority is the promotion and development of a freight strategy with funding of \$200m per year for five years to address first and last mile access issues, leading to an increase in local, regional and national productivity.



Roads to Recovery

The Roads to Recovery Program provides councils with essential additional funding to help address the backlog of maintenance and renewal of local roads. Success was achieved with Roads to Recovery by having the expiration date removed and essentially creating an ongoing program. Further work in this area is being undertaken to ensure Roads to Recovery funding is permanently doubled.



Additional Local Roads Funding for South Australia

Additional funding for South Australian local roads to address an anomaly in FAGs ceased in 2014. It was reinstated in 2017–18 but only for two years. The focus is now on securing ongoing additional funding for South Australian local roads, indexed annually in line with FAGs.



Climate Change Plans

Many councils are addressing or wish to address climate change. With the important role Local Government can play helping the Australian Government to achieve internationally agreed climate change targets, a priority has been placed on supporting councils to work with local businesses and communities to implement local and regional Climate Change Adaptation Plans.



Indigenous

Addressing Indigenous disadvantage across Australia is a priority for all Australian governments. Advocacy is about closing the gap between Indigenous and non-Indigenous Australians in the areas of housing, health, early childhood development, education, economic participation and remote service delivery.



Community Infrastructure

Funding support for community infrastructure will enable all local councils to plan and deliver adequate and appropriate community infrastructure. ALGA is urging political parties to commit to specific local government community infrastructure funding at the level of \$300 million per annum over the next four years.
